4. This Provisional affiliation subject to the condition of deposit of affiliation fee which must be deposited within a week from the date of receipt of this letter. Ignore if you already paid.

In light of university notification vide letter no. 004/FIN/038/AKU/2014-1323, dated 18-05-2020, the college is directed to deposit the amount of Endowment Fee 5,00000/- (Five Lakhs only) in any nationalised/scheduled bank branch as Fixed Deposit in the name of college and thereafter the said FD will be pledge infavour of the Registrar, Aryabhatta Knowledge University, Patna within a period of 03(Months) week to the University from the date of issue of this letter.
